2. In this regard, it is certified that the institution namely SATYA KINKARDEY ACADEMY, has fulfilled all the NCTE Regulations 2014 as amended from time to time and Norms & Standards prescribed by NCTE for B.Ed. Course/ Programme and is running this course/ Programme successfully with due affiliation of this affiliating body/ University.
- 2a. In terms of Govt. Notification No. 697-Edn(U)/1U(WBUTTE)-11/15 Dated 17/07/2021. All the Colleges so far affiliated under the University of Burdwan came under the affiliation of this University.

Because of shortage of adequate infrastructural facilities, a Govt. Of W.B. Undertaking, WEBEL was given the responsibility of inspecting these colleges prior to their induction. This was done virtually by WEBEL and they cleared the Colleges.

Since in 2021-2022 papers of these colleges were scrutinised by the B.U. we are unable to comment on it save and except that, the Burdwan University had cleared these colleges.

For 2022-2023 the University will not guarantee the physical presence of the faculties as because of stiff resistances from many private colleges, this could not be done and their presence is certified based on papers submitted by the colleges, as is done by the NCTE. The University will also not guarantee the genuineness of the Bank statements, ensuring the quantum and the payment of teacher's salary through Bank. As there has been a number of complaints of submission of self-prepared and fake bank statements by the colleges and the university, being a third party, will not be allowed by any bank of a college to verify the genuineness of the Bank statements.
